

The regular meeting of the Bristol Council was held in the Townhall on March 1, 2010 at 8:00 p.m. with Mayor Brent Orr, and Crs. Steve Forbes, Keith Smith, Colette O'Malley, Greg Graham, and Brian Drummond.

**(10-03-29)** Motion Cr. Forbes that the minutes from the February 1st meeting be adopted. Crd. The Mayor abstains from voting.

**(10-03-30)** Motion Cr. Drummond that the agenda be adopted with the additions. Crd. The Mayor abstains from voting.

The meeting was opened to the visitors present.

Sheila Watt was present to promote the Thom bus line service due to the complaint registered by the MRC that in her opinion was unwarranted. The complaint pertained to their service and schedule which the MRC were informed was not being followed. In the future, she questioned if the MRC could verify issues with frequent riders before registering a formal complaint against the bus company. She also inquired if the bus schedule could be posted on our web site to encourage more users.

Peter Hanna questioned the status of the intrench disposal site closure, the location of the transfer station, and procedures for the disposal of waste and he also inquired about the route proposed for the Quad Trails through Norway Bay.
