

The regular meeting of the Bristol Council was held in the Townhall on October 4, 2010 at 8:00 p.m. with Mayor Brent Orr, and Crs. Steve Forbes, Keith Smith, Colette O'Malley, Greg Graham, Brian Drummond and Debbie Kilgour.

**(10-10-153)** Motion Cr. Forbes that the minutes from the September 7th meeting be adopted with the revision to motion (10-09-146) stating that Cr. Graham registers his dissidence. Crd. The Mayor abstains from voting.

**(10-10-154)** Motion Cr. O'Malley to adopt the agenda with the additions. Crd. The Mayor abstains from voting.

The meeting was opened to the visitors present.

Sheila Watt inquired if the street light at the corner of Aylmer Road and Highway 148 could be repositioned to increase visibility and she stated that the bulb needs to be changed. She also inquired if the municipality could mark the entrance to the park & ride.

Mrs. Egan thanked council for the culvert recently installed at the pier.

Bonnie Beveridge inquired when the deer crossing signs would be installed on River Road between Wharf and Pine Lodge.

Doreen Harry commented that she was impressed that the councillors were facing the public instead of each other. She also stated that the Fall Clean Up is just a ploy by council to increase the tonnage of waste in our municipality. She also inquired about the recycling contract.

Michel Harry inquired if we are still in the process of attempting to renegotiate the waste disposal contract.

Doreen Harry asked if a street light could be installed at 38 Fifth Line East.

**(10-10-155)** Motion Cr. Forbes to accept the tender of Trevor Murdock for snowplowing at the # 2 Firehall at a cost of \$598.24 taxes included. Crd. The Mayor abstains from voting.

- (10-10-156)** Motion Cr. Drummond to accept the tender from Kelly Brothers Equipment Rentals for winter road maintenance for the 2010-2011 season consisting of 81.77 km north of Highway 148 at a cost of \$1868.08 per kilometre taxes included. Crd. The Mayor abstains from voting.
- (10-10-157)** Motion Cr. Forbes that we accept the report from the Building Inspector, Marleen Bélisle, concerning an inspection at 94 River Road, which states that all allegations against Greg & Joan Dunn are false in terms of all applicable building codes in the Municipality of Bristol. Crd. The Mayor abstains from voting.
- (10-10-158)** Motion Cr. Drummond to allocate \$300 to Rebecca McKay as the recipient of the Municipality of Bristol Bursary and also \$300 to Curtis Gagnon as the recipient of the Louis Welsh Memorial Fund. Crd. The Mayor abstains from voting.
- (10-10-159)** Motion Cr. Drummond to direct the Town Planning Committee to research what is feasible for construction on the RVI property. Crd. The Mayor abstains from voting.
- (10-10-160)** Motion Cr. Forbes to send a letter thanking Score Financial Services for their quote and notify them that the municipality has decided to remain with Sunlife for employee health benefits. Crd. The Mayor abstains from voting.
- (10-10-161)** Motion Cr. O'Malley to ask the BCA to apply for the liquor permit for the Christmas party scheduled for December 18<sup>th</sup> and to develop a check list for lock up procedures when there is no representative from the BCA at a function. Crd. The Mayor abstains from voting.
- (10-10-162)** Motion Cr. Forbes to apply for a rink attendant through Emploi Quebec at a rate of \$12.00 and that the Director General be authorized to sign any correspondence pertaining to this application. Crd. The Mayor abstains from voting.
- (10-10-163)** Motion Cr. Forbes to accept the quote from Campbell's Bay Ciment for the supply of winter sand and to accept the quote from Kelly Brothers Equipment Rentals for hauling. Crd. The Mayor abstains from voting.
