The regular meeting of the Bristol Council was held in the Townhall on August 2nd, 2011 at 8:00 p.m. with Mayor Brent Orr, and Crs. Steve Forbes, Keith Smith, Colette O'Malley, Greg Graham, Brian Drummond and Debbie Kilgour.

(11-08-138)	Motion Cr. Kilgour that the minutes from the July 4th meeting be adopted as presented. Crd. The Mayor abstains from voting.

The results of the register were announced to the public.

The meeting was opened to the visitors present.

Paul Hinch questioned if the Municipality of Bristol had committed to substantial financial contributions towards the Sault-des-Chats project and if are considered a major or minor partner.

A ratepayer thanked council for the garbage can installed on the access way at the end of Graham Street and also questioned when the damage caused by the recent storm to that access way would be repaired.

Winnifred Pirie inquired if the park at the pier could be raked. In addition, she congratulated council for their decision to proceed with the paving of Elmside Road.

Peter Hanna questioned if the gravel tax money could be used towards the paving of Elmside Road, and he inquired if any of the gravel tax money has been spent to date. He also questioned if there were any other sources of income to help offset the cost of paving Elmside Road.

Sheila Watt questioned Animal Control By-Law # 162-2010 issued by the MRC.

Ted Ambridge questioned the accounting procedures, specifically issues with the balancing of the trial balance.

Michel Harry questioned why the public notice for the register for Borrowing By-Law # 291 was not published in any newspapers. He also inquired why the gravel was removed from the Fifth Line East. In addition, he questioned Road Foreman Derek O'Malley's qualifications. Doreen Harry complained about the segregation of the telephone book. In addition she stated that the minutes are never reported correctly in terms of questions she asks.

Diane Wilson questioned the process for posting the public notice and the requirements for entering your name on the registry for Borrowing By-Law # 291. She also inquired if the posting of the public notice would have been better advertised if the condo project proposed for the former R.V.I. site would have proceeded. In addition, she complained that the public notice did not indicate that all ratepayers could vote. She also asked that in the future if the municipality has to borrow money that the public could be better informed.

Sheila Watt stated that council should do a better job of keeping the ratepayers informed and that Municipal Affairs requirements are not adequate.
