- (12-05-71)** Motion Cr. Drummond that the minutes from the April 2nd meeting be adopted as presented. Crd. The Mayor abstains from voting.
- (12-05-72)** Motion Cr. Forbes to adopt the agenda with the additions. Crd. The Mayor abstains from voting.
- (12-05-73)** Cr. Forbes gives notice of motion to introduce a by-law to legally adopt the Fire Safety Service. Crd. The Mayor abstains from voting.
- (12-05-74)** Motion Cr. O'Malley to nominate Cr. Graham as the TPR (Transport Pontiac Renfrew) representative. Crd. The Mayor abstains from voting.
- (12-05-75)** Motion Cr. Drummond to sign an Intermunicipal Agreement with the Municipality of Campbell's Bay and that Mayor Brent Orr and Director General Christina Peck are authorized to sign. Crd. The Mayor abstains from voting.
